We have provided a list of rules that participants will need to follow in order to participate. These rules are in place for the safety of the participants, so please make sure to review them carefully.

PROGRAM RULES TO REMEMBER:

- **Parents must be present at all times. This is for the safety of all participants.**
- **Animals do not mind hearing the same story repeatedly, as long as you speak to them in a quiet, soothing, calm voice.**
- **Do not touch the dogs, unless given permission by a staff member.**
- **Rotate to a new reading partner only upon instruction from staff.**
- **No running permitted on shelter property ever.**
- **No loud noises or distractions. Our program is designed to lessen the effects of stress in a shelter.**
- **Do not offer the animals any food without consent of shelter staff.**
